## PLEDGE OF ALLEGIANCE

Commissioner Dunning led all in attendance in reciting the Pledge of Allegiance.

## ADOPTION OF AGENDA

Commissioner Dunning moved, and Commissioner Schwab seconded, to adopt the agenda as presented. Motion unanimously carried.

## **PUBLIC COMMENTS**

## APPROVAL OF MINUTES

Commissioner Dunning moved, and Commissioner Schwab seconded, to approve the minutes of the Port Commissioner meeting held on Thursday, February 08, 2024, as presented. Motion passed unanimously.

## FINANCIAL REPORTING

Port Auditor/Treasurer Keown provided Commissioners the Cash Balance Report and Financial Reports for both the Port and the Airport.

## **PAYMENT OF BILLS**

The Port Commission reviewed Port and Airport Check History Report lists as provided by Port Auditor/Treasurer Keown. Said lists were audited, authenticated, and certified as required per RCW 42.24.080 and reimbursement claims were certified as required by RCW 42.24.090. Commissioner Schwab moved, and Commissioner Dunning seconded, to approve for payment the Check History Report lists summarized in the February 22, 2024, Warrant Approval Document, which is incorporated and attached to these minutes. Motion unanimously carried.

## **OLD BUSINESS**

## A. Port of Walla Walla

## 1. Tourism Fund Grants – Second Round

Executive Director Reay reviewed with Commissioners the Port's 2024 Tourism request application and reminded the Commission that the applicants can only use the funds for purposes to promote tourism consistent with the Port's Tourism Policy. Commissioner Schwab moved, and Commissioner Dunning seconded, to approve the second round of tourism applications and requests and allocate said funds from the Port's 2024 tourism funds in amounts determined by the Port Commission, as identified in Exhibit 2 of the staff report. Round two of tourism grant funding will be in the amount of \$7,000. Motion passed unanimously.

## **NEW BUSINESS**

## A. Port of Walla Walla

## 1. <u>0.09ths EDSTF – Walla Walla Public Schools – Multi Sport Community</u> Complex Project

Executive Director Reay reviewed with Commissioners the request for funds to construct a multi-sport community complex project and described how the use of the funds for that purpose was likely to benefit the community financially. Commissioner Schwab moved, and Commissioner Dunning seconded, to approve an Economic Development Sales Tax Fund grant under the "Non-Economic Development Project" criteria in the amount of \$200,000 to Walla Walla Public Schools – Multi Sport Community Complex Project, and to authorize the Executive Director to submit said application to the Walla Walla County Board of Commissioners for their concurrence. Motion passed unanimously.

## 2. <u>0.09ths EDSTF – Rural Library District – Touchet Library Construction</u> <u>Project</u>

Executive Director Reay reviewed with Commissioners the funding request to construct a new library in Touchet. Ana Romero, Rural Library District Executive Director, spoke in favor of the request. Commissioner Schwab moved, and Commissioner Dunning seconded, to approve an Economic Development Sales Tax Fund grant under the "Non-Economic Development Project" criteria in the amount of \$200,000 to Walla Walla County Rural Library District – Touchet Library Construction Project and to authorize the Executive Director to submit

said application to the Walla Walla County Board of Commissioners for their concurrence. Motion passed unanimously.

#### B. Walla Walla Regional Airport

<u>Mead & Hunt Engineering Agreement – 2<sup>nd</sup> Floor Terminal</u>
Airport Manager Skoglund reviewed with Commissioners the proposed updated engineering agreement with Mead & Hunt related to the terminal 2<sup>nd</sup> floor office remodel, and replacement of the boilers and rooftop condensing units. Commissioner Dunning moved, and Commissioner Schwab seconded, to authorize the Executive Director to enter into an engineering agreement with Mead & Hunt Engineers for the Passenger Terminal Building 2<sup>nd</sup> floor remodel & HVAC improvements in the amount of \$355,346. Motion passed unanimously.

#### 2. Alembic, LLC Lease Agreement

Airport Manager Skoglund presented the proposed lease terms for the 1,395 square feet of space located at 102 W. Aeronca. Commissioner Dunning moved, and Commissioner Schwab seconded, to authorize the Executive Directo to enter into an eight (8) year lease agreement with Alembic, LLC, for 1,395 square feet of space in building located at 102 W. Aeronca Avenue as presented. Motion passed unanimously.

#### 3. **Bi-Kay Farms Recap**

Brent Golden, Bi-Kay Farms, Inc., a Port tenant, provided Commissioner with a 2023 crop yield report and a proposed 2024 farm plan. Commissioners and staff thanked Mr. Golden for working well with Airport staff and being considerate of the Airport Business Park tenants.
