## A RESOLUTION OF THE PORT OF WALLA WALLA ADOPTING AMENDMENT NO. 4 TO THE COMPREHENSIVE PORT PLAN

WHEREAS, the Port Commission adopted on December 27, 2012 a new Comprehensive Port Plan (Resolution No. 12-27-12) in accordance with RCW 53.20.010; and

WHEREAS, the Port Commission adopted on July 11, 2013 Amendment No. 1 (Resolution No. 07-11-13) to reflect the acquisition of the Stearns property; and on November 14, 2013 Amendment No. 2 (Resolution No. 11-14-13-A) acquisition of the Martin Archery property; and on September 11, 2014 Amendment No. 3 (Resolution No. 09-11-14) acquisition of Boise White Paper rail line property; and

WHEREAS, the Port Commission intends to further amend the Comprehensive Port Plan to provide for the acquisition of certain real estate; and

WHEREAS, the acquisition of real estate is consistent with Chapter 5: Goals, Policies & Implementing Strategies of the Comprehensive Port Plan; and

WHEREAS, the Port Commission has held on this date a public hearing as required per RCW 53.20.020,

**NOW, THEREFORE, BE IT RESOLVED,** the Comprehensive Port Plan of the Port of Walla Walla is hereby amended by the adoption of this Amendment No. 4 to reflect the acquisition of approximately 0.27 acres of property adjacent to the Port's Dodd Road Industrial Park from the State of Washington/WSDOT and is more particularly described on attached Exhibit A and A-1. Said described property is hereby incorporated into and is now part of the Comprehensive Port Plan of the Port of Walla Walla.
